Weatherable decorated sheet.

Lexan Exell D Venetian sheet is a decorated transparent polycarbonate sheet with proprietary UV protection on one side, offering excellent weathering properties. One side has been decorated with a colored stripe-or honeycomb pattern. The sheets are thermoformable and may be applied in curved applications as well, offering freedom and flexibility in design. Combined with the excellent impact resistance it is an excellent candidate for a wide variety of building and construction applications such as skylights, walkways, barrel-vaults, roof-domes and decorated glazing applications.

Lexan Exell D Venetian and Venetian Honeycomb sheet are decorated on the reverse side with either a stripe or Honeycomb pattern which in addition to nice aesthetics, may provide a reduction of heath build-up. This reduction of heat build-up beneath the sheet , e.g. inside the building is caused by the absorbance of the infra-red rays of the sunlight whilst maintaining a good visible light transmission. The Lexan Exell D Venetian and Venetian Honeycomb sheet is essentially opaque to all wave lengths below 385 nanometers . This useful shielding property can help prevent discoloration of sensitive materials placed under or behind the sheet. Be aware that Lexan Exell D Venetian and Venetian Honeycomb are subject to color impression variances from production lot to production lot hence we advise using a single production lot per project.

The complete Lexan Exell D Venetian sheet range features a proprietary surface treatment designed to help protect the sheet against the degrading effect of ultra-violet radiation in natural sunlight . The un-decorated side must always be installed facing outward and the decorated side must always be facing inwards to avoid direct sun-light on the decoration ink.

Fire Performance

The complete Lexan Exell D Venetian and Venetian Honeycomb is expected to have a good fire performance against many national fire codes. A test program is on-going.
